- **Fast Track to Innovation (FTI)**

FTI supports actions undertaking innovation from the demonstration stage through to market uptake, including activities such as piloting, test-beds, systems validation in real-world working conditions, validation of business models, pre-normative research, and standard-setting. The maximum EU

**SME instrument** (EIC Accelerator Pilot) - From concept to market: Phase 2 helps you develop your business concept further into a market-ready product, service or process aligned with your company's growth strategy. Activities could, for example, include product/service development, trials, prototyping, validation, demonstration and testing in real-world conditions, and market replication. If the activity concerns a primarily technological innovation, a Technology Readiness Level (TRL) of 6 or above is required. Phase 2 offers a grant only support to SMEs in need of one last push before the scaling-up phase; and it will offer blended finance (combining grant and equity to SMEs looking to further develop their idea.

**SME Instrument** wyłącznie MŚP mogą aplikować o finansowanie; w przypadku, gdy mają one zamiar współpracować z uniwersytetami lub innymi organizacjami, mogą one zlecać im zadania wyłącznie na zasadzie podwykonawstwa.
